Research

Doctoral thesis titled "Effect of Business Group and Industry Affiliation on Firm Performance" examined performance effects on Indian Business Group affiliated firms from 1995 to 2006. The study attempted a Variance Decomposition of the performance of Indian business group affiliated firms and determined various effects on their performance in terms of macro-economic influences, industry participation, corporate-parent, and the company effect. The underlying rationale behind these expectations is as follows. Macro fluctuations are proxied by “year”. The industry in which a firm is active has an influence on its performance due to factors specific to that industry. The corporate parent can affect the affiliated firm’s performance through resource facilitation, management bandwidth, by lending reputation, and helping in getting finances. The company due to its resources/endowments and its own capabilities impact its own performance.

- A holistic and multidisciplinary education would aim to develop all capacities of human beings -intellectual, aesthetic, social, physical, emotional, and moral in an integrated manner.
- Such a holistic education shall be, in the long term, the approach of all undergraduate programs, including those in professional, technical, and vocational disciplines.
- Imaginative and flexible curricular structures will enable creative combinations of disciplines for study, and would offer multiple entry and exit points.
- Curricula of all HEIs shall include credit-based courses and projects in the areas of community engagement and service, environmental education, and value-based education.
- The undergraduate degree will be of either 3 or 4-year duration, with multiple exit options within this period, with appropriate certifications, e.g., a certificate after completing 1 year in a discipline or field including vocational and professional areas, or a diploma after 2 years of study, or a Bachelor's degree after a 3-year program. The 4-year multidisciplinary Bachelor's program, however, shall be the preferred option.
- An Academic Bank of Credit (ABC) shall be established which would digitally store the academic credits earned from various recognized HEIs so that the degrees from an HEI can be awarded taking into account credits earned.
- The 4-year program may also lead to a degree 'with Research' if the student completes a rigorous research project in their major area(s) of study as specified by the HEI.
- Model public universities for holistic and multidisciplinary education, at par with IITs, IIMs, etc., called MERUs (Multidisciplinary Education and Research Universities) will be set up and will aim to attain the highest global standards in quality education.
- HEIs will focus on research and innovation by setting up start-up incubation centers, technology development centers, centers in frontier areas of research, greater industry- academic linkages, and interdisciplinary research including humanities and social sciences research.

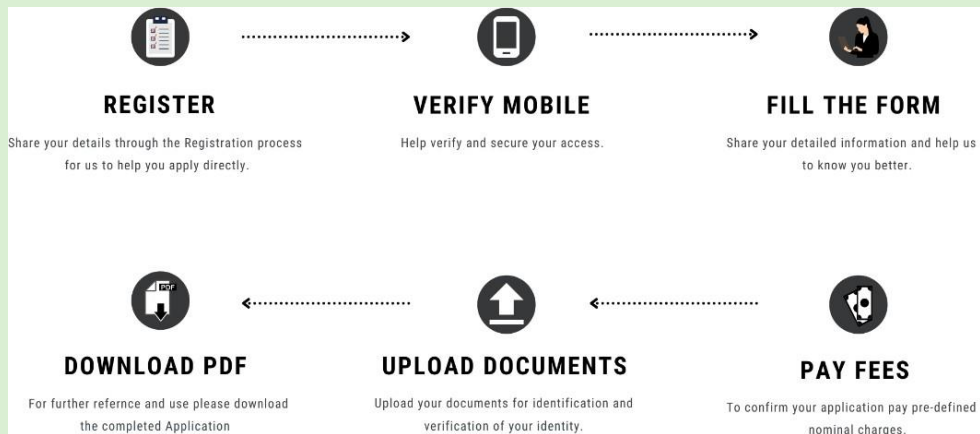

8. International students and collaboration

Admission Guidelines for International Students

International Students have to ensure that they fulfill the following basic criteria for application as International Student.

Nationality:

Please note, only International applicants are eligible to apply through the International Admission Channel/ Process.

By 'International' we mean - Any person who is not an Indian Citizen or a Permanent Resident of India. Similarly, all foreign nationals, Person of Indian Origin (PIO) cardholders, Overseas Citizen of India (OCI - Dual citizens), Non-Resident of India (NRI)'s are considered under the category of International students.

We do not consider NRI Sponsored students or Indian students who have completed any previous Degree/Diploma abroad if they have returned to India or hold an Indian passport under the category of International students. Such applicants have to apply through the Indian Admission Channel.

Please note, students who are applying through NRI/ PIO/ OCI category have to make sure that they fulfill the following Govt. of India criteria to be eligible to apply. D Y PATIL UNIVERSITY follows the Govt. of India – Foreign Exchange Management Act - (FEMA) rules to access the eligibility:

Definition of Person of Indian Origin PIO (Regulation 2(XII) of FEMA 5):

A citizen of a foreign country (other than a citizen of Bangladesh or Pakistan) is a PIO if

1. He/she at any time held an Indian passport; OR
2. He/she or either of his/her parents or either any of his/ her grandparents was a citizen of India;
3. He/she is a spouse (not being a citizen of Bangladesh or Pakistan) of an Indian citizen or (a) or (b) above.

Definition of Non-Resident Indian -NRI(Regulation 2(vi) of FEMA 5):

A Non-Resident Indian (NRI) is

1. an Indian Citizen who resides in India for less than one hundred & eighty-two days during the preceding financial year, or
2. one who has gone out of India or who stays outside India for employment, or
3. who has gone out of India or who stays outside India for carrying on business or vocation outside India, or
4. who has gone out of India or who stays outside India for any other purpose indicating his intention to stay outside India for an uncertain period.

Definition of Overseas Citizen of India- OCI:

An Overseas Citizen of India is a lifetime visa status. It is the closest thing to dual citizenship that India offers. This is applicable on

1. A person who used to be an Indian citizen
2. A person who holds an OCI card
3. A person with at least one parent, grandparent, or great-grandparent who is/was an Indian citizen
4. A person married to an Indian citizen or an existing OCI for at least two continuous years

Program Specific Eligibility and Other Requirements :

Please note, the International Admission Process is very different from the Indian Admission process.

- It is the responsibility of the International applicants to ensure that they fulfill all the basic Eligibility requirements/ criteria for the interested (BBA / MBA) program as mentioned on the official D. Y. PATIL UNIVERSITY Admission website
- It is mandatory to fulfill the basic eligibility requirements related to interested/ applied program(s) to be eligible to apply as incomplete applications or applications that do not fulfill the required background will be disqualified from the application process.
- Kindly note, apart from the basic program-specific eligibility requirements – the International students have to also fulfill the following (additional) requirements for the International admission process i.e.,
 1. Students/ applicants should have minimum of 40% marks/GPA in the 10+2/ Under-graduate/ Master’s degree program to be eligible to apply for the respective program at D. Y. PATIL UNIVERSITY as an International student.
 2. International applicants who are interested in applying for Masters (MBA) program need to have min. 45% in Bachelors / Graduation degree.
 - Proof of English Language Proficiency is essential only for an applicant who has studied in a University located in a non-English speaking country or whose mode of Instruction during previous Degree/ diploma was not English.
 - Or certification of the Proficiency in the English Language issued by the University/College/School from where the candidate has passed her/ his last qualifying examination.
- Kindly note, only those students who have qualified from foreign Universities or Boards of Higher Education, recognized as equivalent by the Association of Indian Universities (AIU), are eligible for admission.
- When required, a reference will be made to the AIU to check the equivalence. The student should submit all the documents mentioned in the eligibility form to check the equivalence through the AIU, along with the application.

Anti Ragging Committee

About the Committee:

Every Institution/Universities/Departments shall constitute a Committee to be known as the Anti-ragging Committee to be nominated and headed by the Head of the Institution, and consisting of representatives of civil and police administration, local media, Non Government Organizations involved in youth activities, representatives of faculty members, representatives of parents, representatives of students belonging to the fresher's category as well as senior students, non-teaching staff; and shall have a diverse mix of membership in terms of level as well as gender.

It shall be the duty of the Anti-Ragging Committee to ensure compliance with the provisions of these Regulations as well as the provisions of any law for the time being in force concerning ragging; and also to monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution.

Functions of Anti Ragging Committee

The Anti-ragging committee will discuss the issue and action will be taken as per the AICTE guidelines.

- The advertisement issued by the Institute shall clearly mention that ragging is totally banned and anyone found guilty of ragging and/or abetting ragging is liable to be punished.
- The 'Prospectus' and other admission related documents shall contain directions of the Supreme Court Affiliating University/admission Authority/HOD shall make it mandatory for the institutions under their jurisdiction to compulsorily incorporate such information in their 'Prospectus'. These Regulations shall be printed in the brochure of admission/instruction booklet for candidates.
- The affidavit should be filled up and signed by the candidate to the effect that he/she is aware of the law regarding prohibition of ragging as well as the punishments, and that he/she, if found guilty of the offence of ragging and/or abetting ragging, is liable to be punished appropriately.
- The application for admission shall be accompanied by a document along with the School Leaving Certificate/Character Certificate which shall include a report on the behavioral patter of the applicant, so that the institution can thereafter keep intense watch upon the student who has a negative entry in this regard.
- Institution maintain a proper record of the affidavits obtained to ensure its safe up keep thereof, including digital copies of the affidavits and such digital copy should be made available to the AICTE.

Advisory Committee:

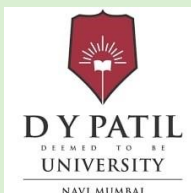
